Directions for Use

Caution: Do not mix with any other chemicals.

For Stopped Up Drains: Slowly pour 16 ounces directly into drain opening. Let stand for 15 minutes. Flush drain with plenty of hot water. If necessary, repeat application and let stand 45 minutes. Badly clogged large industrial drains may require several treatments. Allow to stand overnight before flushing with water.

For Slow Drains: Pour 8 ounces slowly and directly into drain. Repeat procedure 2 or 3 times at 15 minute intervals. After last application, rinse drain thoroughly with hot water.

For Preventative Maintenance: Pour 5 to 16 ounces weekly to keep drains free flowing. Regular use helps prevent build up inside the drain line walls.
