

DIRECTIONS FOR USE

Follow dilution chart to determine proper dilution rate. Use weaker solutions for regular cleaning, depending on the amount and type of soil.

FOR FLOORS: Apply cleaner by mop, scrub with machine if desired, pick up with mop or vacuum, then rinse.

FOR EQUIPMENT & MACHINERY: Spray or wipe product onto surface, rinse lightly, then wipe dry.

FOR AIRPLANES, TRUCK BODIES, Etc: Spray cleaner onto surface and allow to work on soil for up to 5 minutes. Then scrub with a stiff brush and hose off with water. Product may be used on automobiles before waxing.

FOR SMALL PARTS: Dip into solution, rinse lightly, wipe dry.

CAUTION: Do not allow to dry on glass surfaces.

PRECAUTIONS

Keep only in original container. Do not breathe vapours, spray, mist. Wash hands thoroughly after handling. Wear eye protection, protective gloves. If swallowed: rinse mouth. Do NOT induce vomiting. If on skin (or hair): Take off immediately all contaminated clothing. Rinse skin with water/shower. If inhaled: Remove person to fresh air and keep comfortable for breathing. If in eyes: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a doctor. Specific treatment (see First Aid measures on this label). Wash contaminated clothing before reuse. Absorb spillage to prevent material damage. Store locked up. Dispose of contents/container to an approved waste disposal plant.

FIRST AID

Never give anything by mouth to an unconscious person. If you feel unwell, seek medical advice (show the label where possible). **After Inhalation:** Remove victim to fresh air and keep at rest in a position comfortable for breathing. Immediately call a doctor/physician. **After Skin Contact:** Remove/Take off immediately all contaminated clothing. Rinse skin with water/shower. Immediately call a doctor/physician. **After Eye Contact:** Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a doctor/physician. **After Ingestion:** Rinse mouth. Do NOT induce vomiting. Immediately call a doctor/physician.

FIREFIGHTING

Use water spray or fog for cooling exposed containers. Exercise caution when fighting any chemical fire. Prevent fire-fighting water from entering environment.

SAFE HANDLING

Wash hands and other exposed areas with mild soap and water before eating, drinking or smoking and when leaving work. Provide good ventilation in process area to prevent formation of vapour. Do not breathe vapours, spray, mist. Avoid contact during pregnancy/while nursing.
