Directions For Use

SURFACE PREPARATION: Remove large rust and scale particles with a wire brush or sandpaper. Clean the surface thoroughly to remove dirt, dust and grease.

APPLICATION: Shake or stir well before using. **RUST REDUX XL** is ready-to-use. Do not dilute. Apply this product using a brush or roller. Apply a second coat to ensure complete transformation of rusty surfaces.

COVERAGE: 500 square feet per gallon on a smooth, non-porous surface. Irregular, porous or textured surfaces may require more product.


DRYING TIME: The resulting coat will dry to a smooth, dark finish in 20 minutes. Apply a second coat to ensure complete transformation of rusty surfaces. Allow 48 hours of cure time before the application of the finished paint coat.

For long-lasting protection of iron surfaces, the cured rust converter should be sealed with two coats of a high quality oil-based paint. No other primer is required.

CLEAN-UP: Application equipment should be cleaned immediately with soap and water.
