Directions For Use

- STEP 1. Close all windows and shut down air-conditioning or heating unit.
 - STEP 2. Place can on raised surface near middle of room.
 - STEP 3. Spread paper or cloth directly below can for protection.
 - STEP 4. For total discharge, press valve all the way down, locking the catch.
 - STEP 5. Set can down and immediately leave the room.
 - STEP 6. Do not disturb area for at least 2 hours. Ventilate room for 30 minutes before re-entering.
- NOTE: The 360° valve can be operated to give short bursts of spray by lightly depressing the valve and pointing the can to area to be treated.

Precautionary Statement
